STAGE TWO:

KALAELOA ROAD RACE - SUNDAY, JUNE 17

THE ROAD RACE COURSE IS A FAST, FLAT CIRCUIT OF APPROXIMATELY 3.5 MILES, STARTING AND FINISHING ON ROOSEVELT AVENUE. THE COURSE WILL BE RIDDEN CLOCKWISE, MAKING A RIGHT TURN ON TO ENTERPRISE, MAKING A RIGHT TURN ON TO MIDWAY STREET, THEN ON TO BOXER AVENUE, AND RIGHT BACK ON TO ROOSEVELT AVENUE. THE FEED ZONE WILL BE ALONG BOXER AVENUE AND FEEDS MAY ONLY BE RECEIVED ON THE RIGHT SIDE OF THE ROAD.
